



How to get a SUB appliance rebate:

1. Purchase the ENERGY STAR® qualified appliance from the dealer of your choice.
2. Complete, sign and submit the rebate application form below.
3. We will process your application within two weeks. If the application is approved, SUB will credit your account.
If the application is not approved, we will mail you a letter explaining why.
4. Eligible clothes washer or dishwasher must be supplied by an electric water heater.

How to recycle an old refrigerator or freezer:

1. Note: the refrigerator or freezer must be 10 cubic feet or larger and functional.
2. Contact appliance recycler – Appliance Broker at 747-7787 – to pick up the old freezer or refrigerator.
3. Complete, sign and submit the rebate application form below.
4. SUB will confirm that the appliance matches the rebate application and credit your account within two weeks.

Appliances must be installed in the Springfield Utility Board service area to be eligible. Valid within 60 days of purchase only. Programs subject to change. Valid through December 31, 2010.
